# Standard Operating Procedure (SOP)/ Guidelines for selection of Urban farmers under CM-KISAN

#### Introduction

CM-KISAN is a farmers' welfare State Plan Scheme which is being implemented in the State. The prime objective of the scheme is to accelerate agricultural prosperity and to empower the farmers of the State.

The small and marginal farmers of rural areas are included under the scheme and now the Govt. has decided to include urban farmers under the scheme.

The urban small and marginal farmers have to fulfill the following mandatory requisites for registration in CM-KISAN.

## Mandatory requisites for registration

- Registration & land record updation in Krushak Odisha(KO) portal.
- > Linking of Aadhaar number with bank account to be done in respective banks.
- Owning unique mobile number for registration.
- > Copy of Land records.

### Farmer's Registration & Verification

- Urban farmers having land in Urban areas shall register in CM- KISAN portal based on the location of farm land.
- Village Agricultural Worker / Agriculture Overseer ((VAW/AO) assigned for the Urban Local Body shall physically verify that the urban land is under cultivation.
- > In case of documents found incorrect and/or the land is used other than cultivation, the VAW will reject the application.
- After Verification of application at VAW/AO level, Block Agriculture Officer (BAO) and Chief District Agriculture Officer (CDAO) of the district shall verify the application.
- > The eligibility status of beneficiaries will be decided at the level of Collector .
- > The urban small and marginal farmers shall be finally made eligible for CM-KISAN assistance at the State level as per procedure by the Dept.
