MODALITIES OF SPECIAL SATURATION DRIVE FOR CM-KISAN & PM-KISAN

1. Objective

- The aim of the Special Saturation Drive is to include new beneficiaries under PM KISAN and CM KISAN schemes and for fulfilling the mandatory requirements (e-KYC, Land seeding & NPCI seeding) of both schemes.
- Inclusion of LARGE/MEDIUM and Urban Farmers in PM-KISAN scheme.
- Inclusion of left out Rural SMF and LAH in the CM-KISAN scheme.

2. Modalities

- CM-KISAN portal of the State will serve as one-stop registration platform for all category of farmers to enrol themselves as beneficiary for both PM-KISAN and CM-KISAN schemes. Medium, Large Farmers and farmers residing in urban areas shall also apply in CM-KISAN portal for verification and consideration under PM-KISAN scheme as per their eligibility under PM-KISAN.
- The Special Saturation Drive under PM-KISAN scheme will commence on 08th Sept 2024 on the auspicious occasion of Nuakhai and will continue for 2 months till 08.11.2024.
- All category of farmers registered with land holdings (Small, Medium, Marginal & Large), landless & farmers residing in Urban areas can enrol themselves free of cost at nearest CSCs.
- However, for new beneficiaries fulfilment of land details requirement i.e updation of land details in Krushak Odisha Portal will be done by the beneficiary at his own cost.
- Farmers belonging to Urban areas can register for PM-KISAN benefits for CM-KISAN portal only.
- Farmers belonging to Medium, Large category can also register in CM KISAN portal to be included in the PM-KISAN beneficiary list.
- The Krushi Samruddhi Helpline Team personnel have been trained along with the CSC master trainers & scheme officers at district level regarding the Special Saturation Drive to guide the farmers upon their queries.
 The detail of assistance under different category is mentioned

(i) Small Marginal Farmers (SMF): Land holdings less than 2 hectares



- (ii) Medium/ Large Farmers (MLF): Land holdings more than 2 hectares only for P.M-KISAN applicants
- (iii) Landless Agriculture Household (LAH): MGNREGA job Card is required for LAH for enrollment under CM-KISAN.

3. Role of Farmers

- The beneficiaries were enrolled in KALIA scheme as SMF & LAH category farmers, need not to apply again.
- Similarly, the beneficiaries who are already getting PM-KISAN assistance they need not to enrol again in CM-KISAN portal.
- The eligible farmers under PM-KISAN scheme who are not getting financial assistance due to non fulfilment of mandatory activities can do
 - a. e-KYC updation in PM-KISAN portal,
 - b. Land seeding in Krushak Odisha (KO) portal at the nearest CSCs.
 - c. NPCI seeding they can visit their Aadhar linked nationalized banks or India Post Payments Bank for successful linking of aadhar with bank account.
 - The e-KYC updation of already registered beneficiaries can be done in PM-KISAN portal free of cost in all the CSCs across the state during the Saturation Drive period till fully integration of CM-KISAN & PM-KISAN portal by Gol. After fully integration of both the portals, the e-KYC updation for both schemes can be done in CM-KISAN portal only. The date will be made public after the process is completed in all aspects.
 - Land record updation can be done in Krushak Odisha portal for already registered beneficiaries of PM-KISAN scheme free of cost in all the CSCs across the state during the Saturation Drive period.
 - Beneficiaries already registered under PM-KISAN portal and payment stopped due to pendency of different mandatory parameters can be fulfilled as mentioned below.

4. Role of Common service Centres

- After getting the pendency information of PM-KISAN, the CSCs will motivate the farmers to complete their mandatory requirement for PM KISAN during the period of saturation drive.
- No further charges will be collected from the farmers for e-KYC, land seeding
 of the farmers in the pendency list (List-1 and List-2) as well as newly
 registered beneficiaries during the saturation drive period.

5. Role of VNOs

- VNOs shall motivate the farmers for enrolment during the saturation drive.
- VNOs will conduct physical verification of documents of farmers.
- They will Inform the process and facilitate farmers to do OTP based e-KYC (152885 Nos.), land seeding and NPCI seeding for the existing beneficiaries.
- The VNOs will be provided with incentives for successful OTP based e-KYC updation. The incentive amount will be intimated after the final approval.
- Verify PVTG farmers/ other tribes with Patta holders for inclusion in both the schemes shall be done as per the guidelines/SOP.
- After receipt of online application in VAW login he/she will verify the same.

6. Role of BAOs

 Block Agriculture Officer will complete the verification at his level and thereafter forward the same the Chief District Agriculture Officer for verification of the same at his level.

7. Role of Collectors and DM

- After completion of all field level verification, final approval will be done at Collector and District magistrate level.
- PVTGs beneficiaries to be included after issue of PVTG certificate as per the SOP communicated to Collectors & DM and CDAOs.

8. NPCI seeding

- SLBC/ DLBC shall issue instructions to all banks for NPCI seeding of PM KISAN beneficiaries on priority basis. A special desk may be set up in all banks to facilitate NPCI seeding of PM KISAN / CM-KISAN beneficiaries during the drive period. The LDM of DLBC
- Indian Postal Payment Bank (IPPB) to extend full cooperation during the saturation drive for NPCI seeding in case of non- availability of any bank accounts in favour of beneficiaries.
